GUIDELINES FOR AUTHORS(S)

Authors are requested to send their submission in the form of Articles, Legislative Comments, Case Comments, Book Reviews, and Normative Law Articles.

Articles	(5,000 to 7,000 words)
Legislative Comments	(3,000 to 5,000 words)
Case Comments	(3,000 to 4,000 words)
Normative Law Articles	(3,000 to 4,000)

1. The author(s) are requested to refer to **Part III ONLY** of the **RGNUL Guideline for Contributors** for the citation style. The **RGNUL Guideline for Contributors** can be accessed at <http://rgnul.ac.in/rlrscheme.pdf>.
2. Manuscript must be accompanied by an abstract of not more than 300 words, which shall outline the area of study and the conclusions drawn by the author(s).
3. Contribution can be made by single author or by way of co-authorship (Maximum of two authors).
4. Manuscript shall also be accompanied by a Covering Letter containing the Author's name, year of study, name of Institution, postal address, Telephone number and e-mail id. *These details must not be mentioned anywhere else within the body of the manuscript.*
5. Submission must contain the manuscript, abstract and covering letter in separate Microsoft Word 2007/2003 documents. Author(s) are requested to e-mail the same to rslr@rgnul.ac.in.
6. The submission deadline for the inaugural issue is 15th April 2014.
7. Author(s) may also be required to revise their manuscript time to time.
8. Author(s) will be required to assign the Copyright to RGNUL, Punjab, in case the manuscript is approved for publication by the RSLR editorial board.
9. All decisions taken by the RSLR will be final and binding upon the Author(s).
